- 1. ALL SAFETY RULES MUST BE OBSERVED.
- 2. RANGE SAFETY OFFICERS ARE IN CHARGE OF ALL RANGE SHOOTING ACTIVITES, *ALWAYS OBEY THEIR COMMANDS*.
- 3. EYE AND EAR PROTECTION IS REQUIRED FOR ALL SHOOTERS AND GUESTS NEAR THE FIRING LINE.
- 4. ON THE FIRING LINE ALL MUZZLES MUST POINT DOWN RANGE AND IF GUN IS UNLOADED ACTIONS ARE TO BE OPEN.
- 5. THIS IS A COLD RANGE, DO NOT BRING LOADED FIREARMS TO THE FIRING LINE, AND DO NOT LEAVE THE FIRING LINE WITH A LOADED GUN!
- 6. NO EATING OR SMOKING ON THE FIRING LINE, ALCOHOLIC BEVERAGES ARE NOT PERMITTED ANYWHERE ON THE RANGE.
- 7. ONLY TARGETS AUTHORIZED BY EAGLE ROCK GUN RANGE MAY BE USED.
- 8. NO TRACERS, ARMOR PIERCING AMMO OR .50 CAL BMG ROUNDS ARE TO BE USED ANYWHERE ON THE RANGE.
- 9. NO FULL AUTO FIREARMS ARE ALLOWED ON THE RANGE.
- 10. NO LITTERING, PLACE YOUR TRASH IN THE RECEPTACLES PROVIDED.
- 11. NO HORSEPLAY ANYWHERE ON THE RANGE.
- 12. NO PETS ALLOWED ON THE RANGE EXCEPT FOR SERVICE ANIMALS.
- 13. ALL INDIVIDUALS UNDER THE AGE OF 18 MUST BE ACCOMPANIED BY A PARENT OR GUARDIAN. DIRECT SUPERVISION BY THE PARENT OR GUARDIAN WHILE THE MINOR UNDER 18 IS ON THE FIRING LINE IS REQUIRED. ADDITIONAL CHILDREN IN THE GROUP WHILE WAITING TO SHOOT MUST BE SUPERVISED BY AN ADULT. THIS GROUP MUST REMAIN IN THE REST AREA BEHIND THE FIRING LINE.
- 14. BEFORE PROCEEDING TO THE FIRING LINE, YOU MUST FIRST SIGN IN AT THE ADMISSIONS BUILDING; GUESTS WHO ARE NOT SHOOTING MUST ALSO SIGN IN.
- 15. ACTS OF VANDALISM WILL BE PROSECUTED UNDER IDAHO CODE 18-7001.
